

## EXHIBIT A LEGAL DESCRIPTION

A VARIABLE WIDTH DRAINAGE EASEMENT SITUATED IN THE SOUTHWEST QUARTER OF SECTION 29, TOWNSHIP 3 SOUTH, RANGE 65 WEST OF THE 6TH PRINCIPAL MERIDIAN, CITY OF AURORA, COUNTY OF ADAMS, STATE OF COLORADO, BEING A PORTION OF TRACT E, THE AURORA HIGHLANDS SUBDIVISION FILING NO. 1 RECORDED AT RECEPTION NO. 2019000089309 IN THE OFFICIAL RECORDS OF THE CLERK AND RECORDER OF SAID COUNTY, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

**COMMENCING** AT THE SOUTH QUARTER CORNER OF SAID SECTION 29, WHENCE THE SOUTH LINE OF SAID SOUTHWEST QUARTER BEARS SOUTH 89°34'42" WEST, A DISTANCE OF 2,645.72 FEET, WITH ALL BEARINGS REFERENCED HEREIN BEING RELATIVE THERETO;

THENCE NORTH 09°34'37" WEST, A DISTANCE OF 1,623.75 FEET TO THE **POINT OF BEGINNING**;

THENCE SOUTH 89°45'52" WEST, A DISTANCE OF 68.16 FEET;

THENCE SOUTH 47°09'13" WEST, A DISTANCE OF 115.00 FEET TO THE BEGINNING OF A NON-TANGENT CURVE CONCAVE SOUTHERLY HAVING A RADIUS OF 95.00 FEET, THE RADIUS POINT OF SAID CURVE BEARS SOUTH 47°09'13" WEST;

THENCE WESTERLY ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 61°41'03", AN ARC LENGTH OF 102.28 FEET TO THE BEGINNING OF A REVERSE CURVE CONCAVE NORTHERLY HAVING A RADIUS OF 160.00 FEET;

THENCE WESTERLY ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 14°23'23", AN ARC LENGTH OF 40.18 FEET;

THENCE TANGENT TO SAID CURVE, SOUTH 89°51'33" WEST, A DISTANCE OF 30.67 FEET;

THENCE NORTH 00°08'27" WEST, A DISTANCE OF 169.44 FEET;

THENCE NORTH 20°07'37" WEST, A DISTANCE OF 202.25 FEET TO THE BEGINNING OF A NON-TANGENT CURVE CONCAVE NORTHWESTERLY HAVING A RADIUS OF 1,635.00 FEET, THE RADIUS POINT OF SAID CURVE BEARS NORTH 23°23'16" WEST;

THENCE NORTHEASTERLY ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 05°40'37", AN ARC LENGTH OF 162.00 FEET;

THENCE TANGENT TO SAID CURVE, NORTH 60°56'05" EAST, A DISTANCE OF 104.52 FEET;

THENCE SOUTH 63°17'57" EAST, A DISTANCE OF 40.18 FEET;

THENCE SOUTH 74°03'55" EAST, A DISTANCE OF 46.97 FEET TO THE BEGINNING OF A NON-TANGENT CURVE CONCAVE WESTERLY HAVING A RADIUS OF 892.00 FEET, THE RADIUS POINT OF SAID CURVE BEARS SOUTH 67°24'00" WEST;

THENCE SOUTHERLY ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 02°30'39", AN ARC LENGTH OF 39.09 FEET;

THENCE NON-TANGENT TO SAID CURVE, NORTH 47°37'53" EAST, A DISTANCE OF 115.51 FEET;

THENCE SOUTH 42°22'07" EAST, A DISTANCE OF 16.00 FEET;

THENCE SOUTH 47°37'53" WEST, A DISTANCE OF 122.25 FEET TO THE BEGINNING OF A NON-TANGENT CURVE CONCAVE WESTERLY HAVING A RADIUS OF 892.00 FEET, THE RADIUS POINT OF SAID CURVE BEARS SOUTH 71°01'34" WEST;

THENCE SOUTHERLY ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 18°38'38", AN ARC LENGTH OF 290.26 FEET;

THENCE NON-TANGENT TO SAID CURVE, SOUTH 00°14'08" EAST, A DISTANCE OF 56.76 FEET TO THE **POINT OF BEGINNING**.

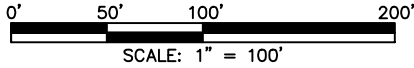

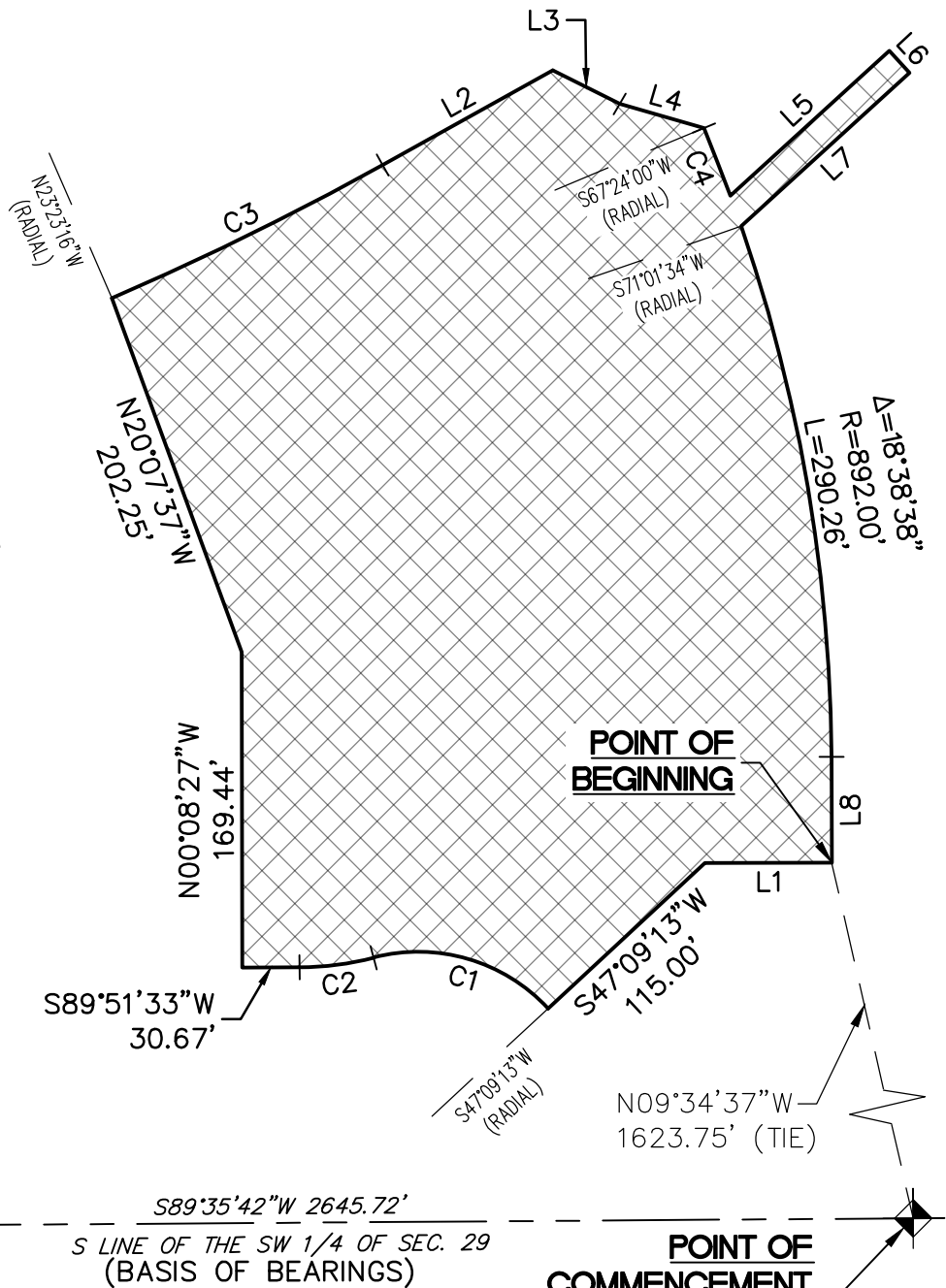
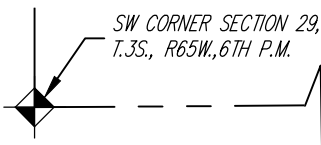
