1.A. Sheet 1 (PW Engineering) – 2nd Review Comments in green were made by PW/Development Services, Engineering reviewer Farhad Sarwari and can be contacted at fsarwari@auroragov.org. Ready for Technical Referral, Minor comments; VTC Note.

1.B. Sheet 1 (PW Engineering) - Repeated Comment: Engineering discussed with Oil and Gas Division and agreed that VTC (Vehicle Tracking Control) pads shall be installed at the entrance of access road to Jewel Ave instead of paving these streets. First 100' of the access road shall be paved when Jewel Ave is paved in this area. Please extend this note or add another note for providing Vehicle Tracking Control Pads.

2. PHA-HAZOP COMMENTS

2.A. Page 2 (Energy & Environment) – Per the Operator Agreement, this site can have a max of 8 wells. This includes the 4 wells that are already in place. Please review and modify to meet OA standards.

2.B. Page 2 (Energy & Environment) – Please add: DA-2395-00.

3. WATER PLAN COMMENTS

3.A. Cover Page (Energy & Environment) – Please reach out to Land Development Review to begin the License Agreement process. If you are crossing any City ROW, easement or utility crossing with layflat lines, you **MUST** apply for a license agreement.

4. AIR QUALITY PLAN COMMENTS

4.A. Page 3 - (Energy & Environment) – Please include BMPs as mentioned in the Operator Agreement.

Reviewer comments not addressed in Rev1, please resubmit in Rev2. Section 6 of this document is a bullet-point list. Bullet-points aren't recognized as sections of a document. Please be as specific as possible as this is a part of a larger application document.

5. TRAFFIC IMPACT STUDY COMMENTS

5.A. Page 1 of 62 (Traffic Engineering) - 2025-01-14 (DJK) reviewed, still one phase missing in Table 1 (renumbered 4 on as "5", equals only 11 phases. Update as necessary.

5.B. Page 1 of 62 (Traffic Engineering) - Table 1 still only identifies 11 phases, just renumbered incorrectly.

5.C. Page 7 of 62 (Traffic Engineering) – Is a step missing? Still only 11 phases, renumbered around '4'.

6. EMERGENCY ACTION PLAN (REDACTED) COMMENTS

6.A. Cover page (Energy & Environment) – Please update year to "2025".

6.B. Table of Contents (Energy & Environment) - Please write out "Job Safety Analysis (JSA)".

6.C. Page 4 of 15 (Energy & Environment) – Please replace easterly to eastward.

6.D. Page 4 of 15 (Energy & Environment) – Please relocate the word map to reflect the word above the actual map.

6.E. Page 10 of 15 (Energy & Environment) - Is the City of Aurora not being notified?

6.F. Page 13 of 15 (Energy & Environment) - Please make sure to acknowledge that the City of Aurora Inspector is out on the



quarterly basis and as needed. Please make sure to include this and when the inspector will be notified of any incidents or spills.
