Response: The crosswalk has been added. Please refer to the SITE PLAN sheet.

- c. Set the existing hydrant back from the curb per the notes provided. (This may be an already addressed old comment).

Response: Comment addressed. The existing fire hydrant should remain. It has been dimensioned and is located 5.5' from the proposed back of curb. This is within range (i.e., less > 3'6" and < 8').
