LAND DESCRIPTION

A PARCEL OF LAND LOCATED IN THE NORTHEAST QUARTER OF SECTION 25, TOWNSHIP 4 SOUTH, RANGE 66 WEST OF THE SIXTH PRINCIPAL MERIDIAN, CITY OF AURORA, COUNTY OF ARAPAHOE, STATE OF COLORADO BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE EAST QUARTER CORNER OF SAID SECTION 25, THENCE ALONG THE EASTERLY LINE OF SAID NORTHEAST QUARTER N00°27'01"W A DISTANCE OF 722.59 FEET, THENCE S89°30'30"W A DISTANCE OF 75.00 FEET TO THE POINT OF BEGINNING;  
THENCE S89°25'57"W A DISTANCE OF 397.00 FEET;  
THENCE N00°27'01"W A DISTANCE OF 560.00 FEET;  
THENCE N89°25'57"E A DISTANCE OF 397.00 FEET;  
THENCE S00°27'01"E A DISTANCE OF 560.00 FEET TO THE POINT OF BEGINNING.

SAID PARCEL CONTAINS 5.104 ACRES OR 222,320 SQUARE FEET MORE OR LESS.




