LEGAL DESCRIPTION

COMMENCING AT THE NORTHWEST CORNER OF SAID SECTION 18, BEING MONUMENTED BY A FOUND NO. 6 REBAR WITH A 3-1/4 INCH DIAMETER ALUMINUM CAP, STAMPED WESTWOOD T3S S12/S7/S13/S18 R66W/R65W 2023 PLS 38004, FROM WHICH THE NORTH QUARTER CORNER OF SAID SECTION 18, BEING MONUMENTED BY A FOUND NO. 6 REBAR WITH A 3-1/4 INCH DIAMETER ALUMINUM CAP, STAMPED WESTWOOD T3S R65W 1/4 S7/S18 2024 PLS 38004, IS ASSUMED TO BEAR NORTH 89°19'43" EAST, A DISTANCE OF 2607.98 FEET, WITH ALL BEARINGS CONTAINED HEREIN BEING RELATIVE THERETO;

THENCE SOUTH 31°40'18" EAST, A DISTANCE OF 4612.92 FEET TO THE **POINT OF BEGINNING**;

THENCE THE FOLLOWING FIVE (5) COURSES;

1. NORTHEASTERLY, A DISTANCE OF 32.26 FEET, ON THE ARC OF A CURVE TO THE LEFT, HAVING A RADIUS OF 20.00 FEET, A CENTRAL ANGLE OF 92°24'43", A CHORD BEARING OF NORTH 22°36'51" EAST, AND A CHORD LENGTH OF 28.87 FEET, TO A POINT OF NON-TANGENTIAL CURVATURE;
2. SOUTHEASTERLY, A DISTANCE OF 3.55 FEET, ON THE ARC OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 1279.97 FEET, A CENTRAL ANGLE OF 00°09'32", A CHORD BEARING OF SOUTH 23°32'42" EAST, AND A CHORD LENGTH OF 3.55 FEET, TO A POINT OF COMPOUND CURVATURE;
3. SOUTHWESTERLY, A DISTANCE OF 32.22 FEET, ON THE ARC OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 20.00 FEET, A CENTRAL ANGLE OF 92°17'46", A CHORD BEARING OF SOUTH 22°40'57" WEST, AND A CHORD LENGTH OF 28.85 FEET, TO A REVERSE CURVATURE;
4. SOUTHWESTERLY, A DISTANCE OF 0.14 FEET, ON THE ARC OF A CURVE TO THE LEFT, HAVING A RADIUS OF 782.00 FEET, A CENTRAL ANGLE OF 00°00'37", A CHORD BEARING OF SOUTH 68°49'31" WEST, AND A CHORD LENGTH OF 0.14 FEET, TO A POINT OF TANGENCY;
5. NORTH 21°10'48" WEST, A DISTANCE OF 3.50 FEET, TO THE **POINT OF BEGINNING**.



POINT OF COMMENCEMENT


