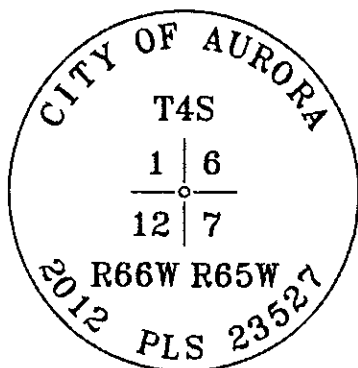

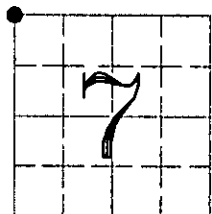

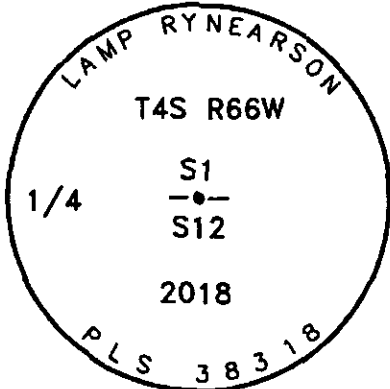
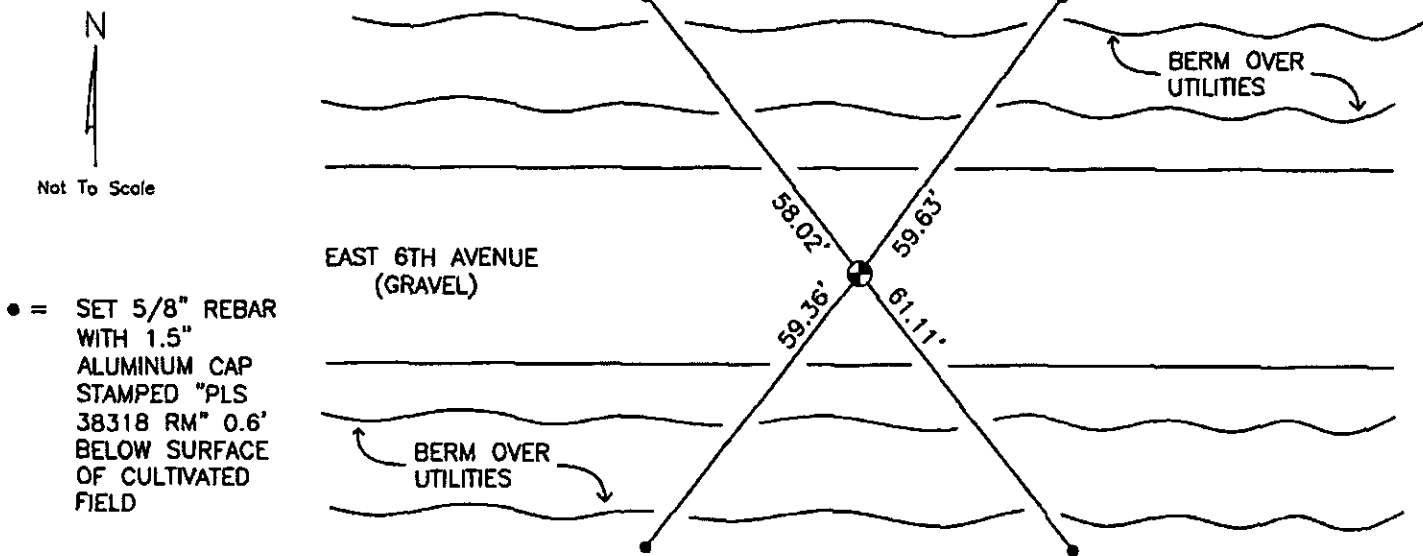
2. DESCRIPTION AND DATE OF MONUMENT FOUND:

FOUND 3.25" ALUMINUM CAP ON 3/4" REBAR IN CITY OF AURORA RANGE BOX, PLS 28257, 1998, 0.4' BELOW SURFACE OF GRAVEL ROAD. THE ENTIRE MONUMENT AND BOX WERE FOUND DISTURBED BY ROAD GRADING OPERATIONS AND LEANING TO THE SOUTHEAST. ALL PREVIOUS TIES HAD BEEN DESTROYED OR DISTURBED BY UTILITY EXCAVATION WORK.

3. DESCRIPTION OF MONUMENT SET BY YOU TO PERPETUATE THE LOCATION OF THIS POINT:

REMOVED EXISTING DISTURBED MONUMENT. SET 30" LENGTH OF 3/4" REBAR WITH 3.25" ALUMINUM CAP, PLS 38318, 2018, STAMPED AS SHOWN, AT BASE OF FOUND MONUMENT 0.8' BELOW SURFACE OF GRAVEL ROAD. POSITION MATCHES TIE DISTANCES TO NORTHEAST, NORTHWEST, AND CENTER QUARTER CORNERS OF SECTION 12 AS SHOWN ON PLAT FILED IN ARAPAHOE COUNTY CLERK AND RECORDER AT RECEPTION NO.D10061. SET NEW TIES AS SHOWN BELOW.

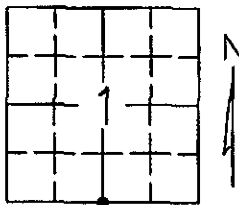

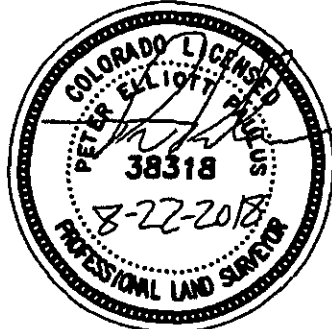

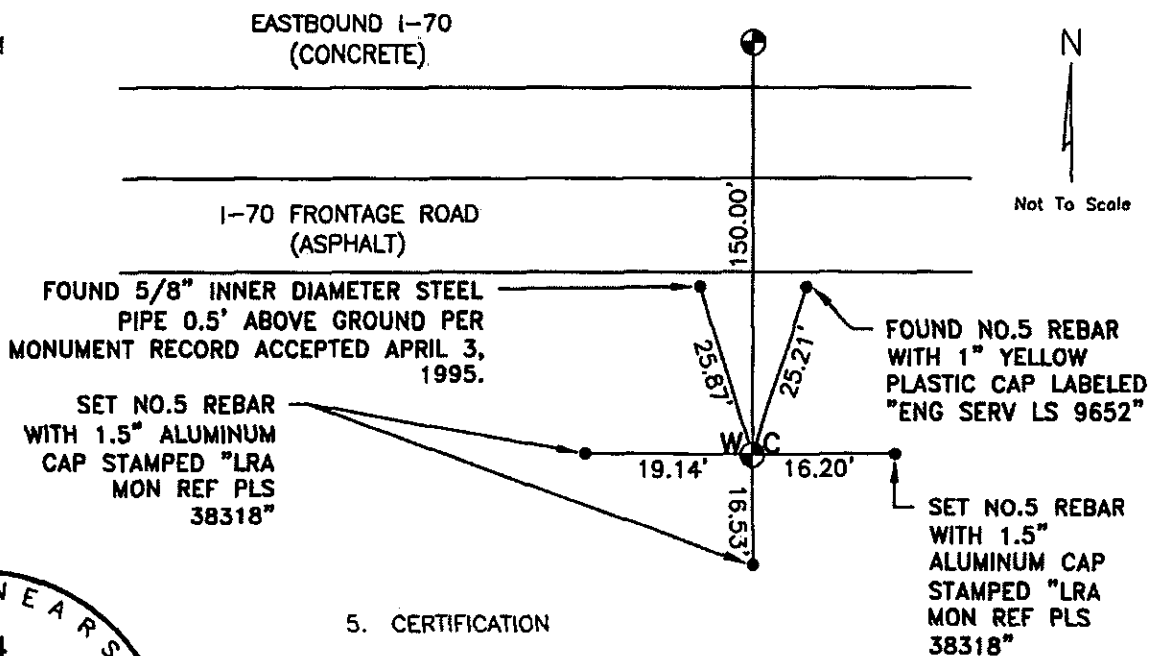

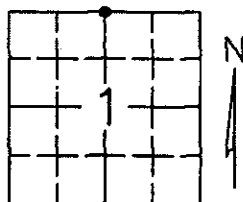
