LEGAL DESCRIPTION:

AN AVIGATION EASEMENT SITUATED IN THE SOUTHEAST QUARTER OF SECTION 8, TOWNSHIP 3 SOUTH, RANGE 65 WEST OF THE SIXTH PRINCIPAL MERIDIAN, CITY OF AURORA, COUNTY OF ADAMS, STATE OF COLORADO, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE EAST QUARTER CORNER OF SAID SECTION 8 AND CONSIDERING THE EAST LINE OF SAID SOUTHEAST QUARTER OF SECTION 8 TO BEAR SOUTH 00°38'22" EAST, WITH ALL BEARINGS CONTAINED HEREIN RELATIVE THERETO;

THENCE SOUTH 02°41'37" WEST A DISTANCE OF 1393.18 FEET TO A POINT ON THE WESTERLY RIGHT-OF-WAY OF POWHATON ROAD RECORDED AT RECEPTION NO. 2017000096931 IN THE RECORDS OF ADAMS COUNTY CLERK AND RECORDER AND THE **POINT OF BEGINNING**;

THENCE SOUTH 00°38'22" EAST AND ALONG SAID WESTERLY RIGHT-OF-WAY A DISTANCE OF 1124.11 FEET TO A POINT OF CURVATURE;

THENCE ALONG A CURVE TO THE RIGHT HAVING A CENTRAL ANGLE OF 90°50'54", A RADIUS OF 25.00 FEET, AN ARC LENGTH OF 39.64 FEET AND A CHORD THAT BEARS SOUTH 44°47'05" WEST A DISTANCE OF 35.62 FEET TO A POINT ON THE NORTHERLY RIGHT-OF-WAY OF EAST 56TH AVENUE AS RECORDED IN BOOK 3677 AT PAGE 359 IN SAID RECORDS OF THE ADAMS COUNTY CLERK AND RECORDER;

THENCE ALONG SAID NORTHERLY RIGHT-OF-WAY NORTH 89°47'28" WEST A DISTANCE OF 508.12 FEET;

THENCE NORTH 00°15'55" EAST A DISTANCE OF 425.09 FEET;

THENCE NORTH 89°44'05" WEST A DISTANCE OF 23.76 FEET;

THENCE NORTH 00°15'55" EAST A DISTANCE OF 440.00 FEET;

THENCE SOUTH 89°44'05" EAST A DISTANCE OF 19.98 FEET;

THENCE NORTH 00°15'55" EAST A DISTANCE OF 273.77 TO A POINT OF CURVATURE;

THENCE ALONG A CURVE TO THE LEFT HAVING A CENTRAL ANGLE OF 23°34'41", A RADIUS OF 27.50 FEET, AN ARC LENGTH OF 11.32 FEET AND A CHORD THAT BEARS NORTH 11°31'26" WEST A DISTANCE OF 11.24 FEET;

THENCE SOUTH 89°44'05" EAST A DISTANCE OF 521.42 FEET TO THE **POINT OF BEGINNING**;

SAID PARCEL CONTAINS AN AREA OF 614,269 SQUARE FEET, OR 14.102 ACRES, MORE OR LESS.

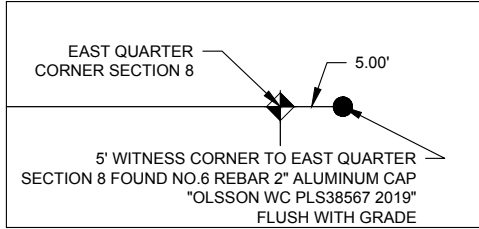

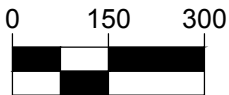

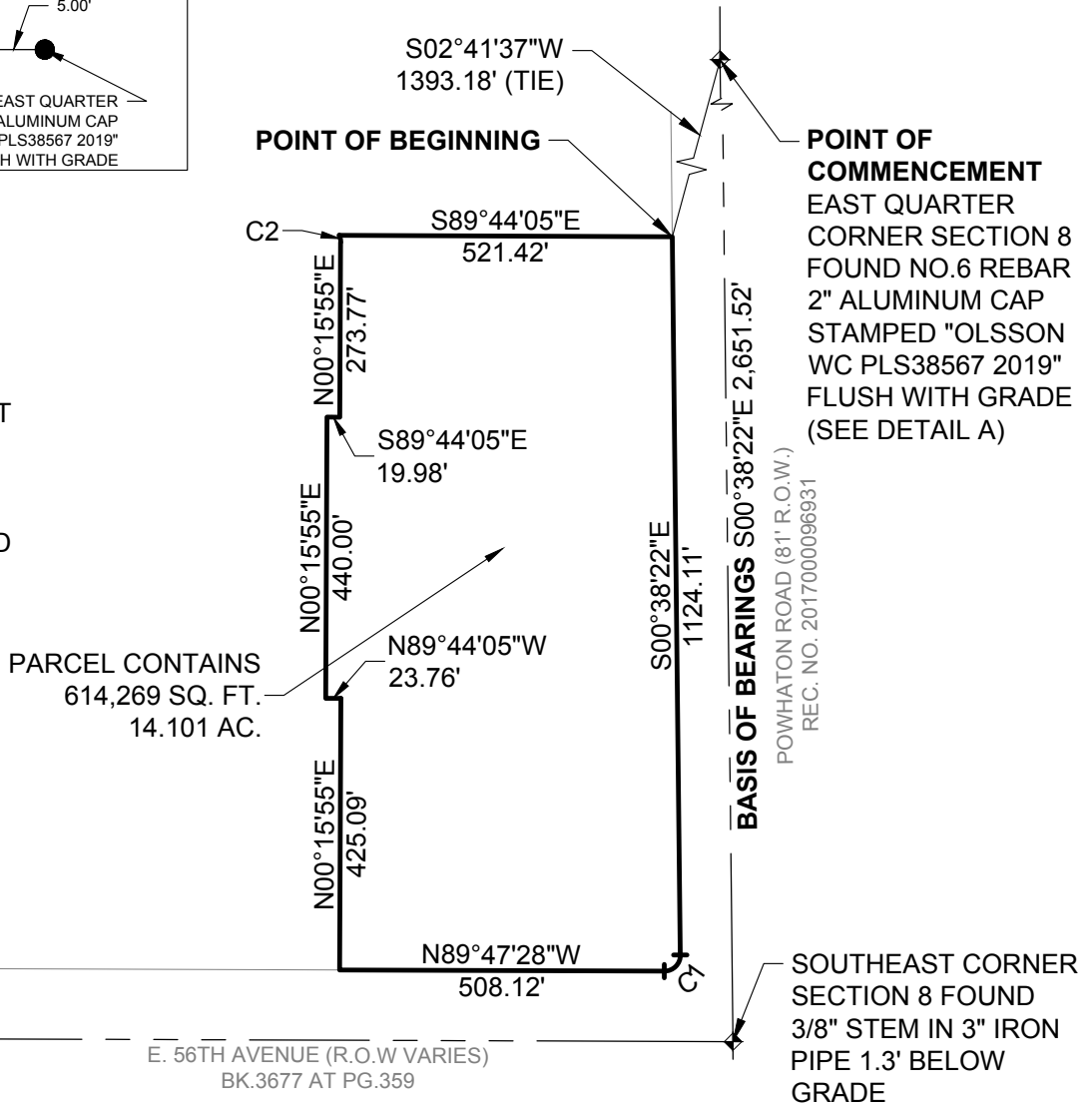
