- i. Please remove the information as shown. Then, please reference the detail and sheet for the propane tank and bollards. Further, the provided drawings show a LP-gas dispenser. Please clarify where this structure will be located.

Strike through lines removed, detail sheet referenced, propane tank and bollards location updated.

1C. Page 5, Sheet C-5:

- i. Please show the location of the proposed structures here and on all applicable sheets. Then add a red cloud and delta 4 around the structures.

Rev cloud, delta 4 and updated tank location shown on all relevant sheets

1D. Page 15, Sheet L-8:

- i. For all details, please include them on an existing sheet if possible. If a new sheet is needed, please label as "Sheet L8A" and add the details. On the details, please note the material and dimensions of all structures (height, width, length, etc.) - we recommend all details be to scale.
