Thank you very much for following up about this and providing the additional information. After internal discussions, I believe we are okay with the trees being removed along Airport Boulevard and would like you to provide a detached 10' sidewalk to match our typical arterial street section.

Along Centretech Parkway, please verify that the existing detached 5' wide sidewalk is ADA compliant and meets the cross slope and longitudinal slope requirements as well. If it does, then the existing 5' wide detached sidewalk would be acceptable to us.
