

KINGS POINT ZONING AMENDMENT MAP

SITUATED IN THE SOUTH HALF OF SECTION 33, 34, AND 35, TOWNSHIP 5 SOUTH, RANGE 66 WEST OF THE SIXTH PRINCIPAL MERIDIAN,

LEGAL DESCRIPTION

PARCEL A – R-1 ZONING

A PARCEL OF LAND LOCATED IN SECTION 35, THE SOUTH HALF OF SECTION 34 AND THE SOUTH HALF OF SECTION 33, TOWNSHIP 5 SOUTH, RANGE 66 WEST, OF THE 6TH PRINCIPAL MERIDIAN, CITY OF AURORA, COUNTY OF ARAPAHOE, STATE OF COLORADO, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BASIS OF BEARINGS: THE EAST LINE OF THE NORTHEAST QUARTER OF SECTION 35, TOWNSHIP 5 SOUTH, RANGE 66 WEST, WAS ASSUMED TO BEAR SOUTH 00°17'32" WEST AND IS MONUMENTED AT THE NORTHEAST CORNER AND THE EAST QUARTER CORNER OF SAID SECTION 35 BY A NO. 6 REBAR WITH A 3-1/4" ALUMINUM CAP STAMPED "RLS 10377 1988 JR ENGINEERING". ALL BEARINGS HEREIN BEING REFERENCE THERETO:

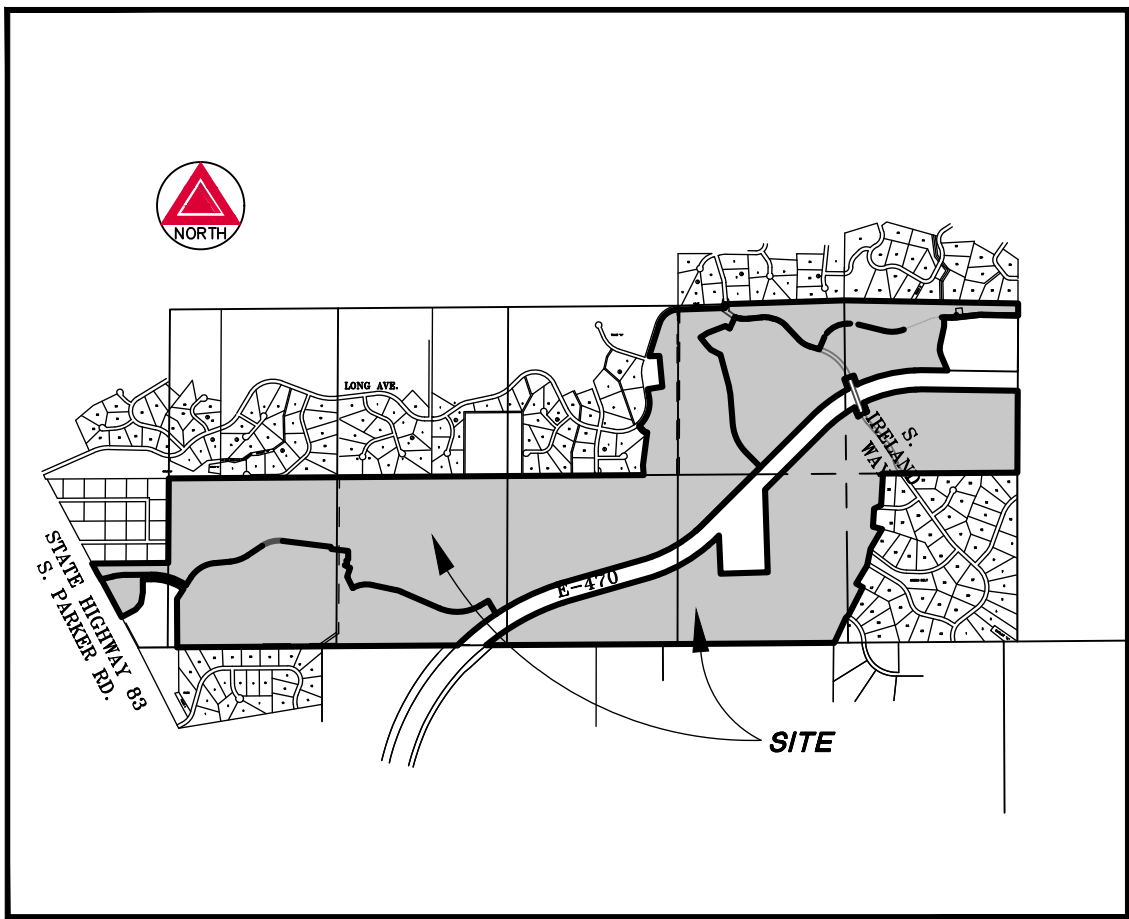

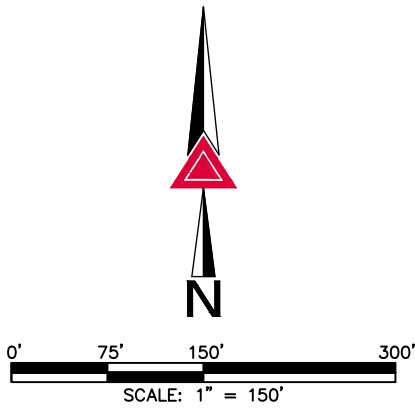
KINGS POINT ZONING AMENDMENT MAP

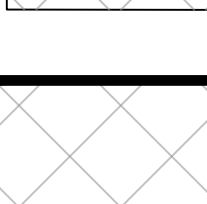
PROPOSED ZONING R-1

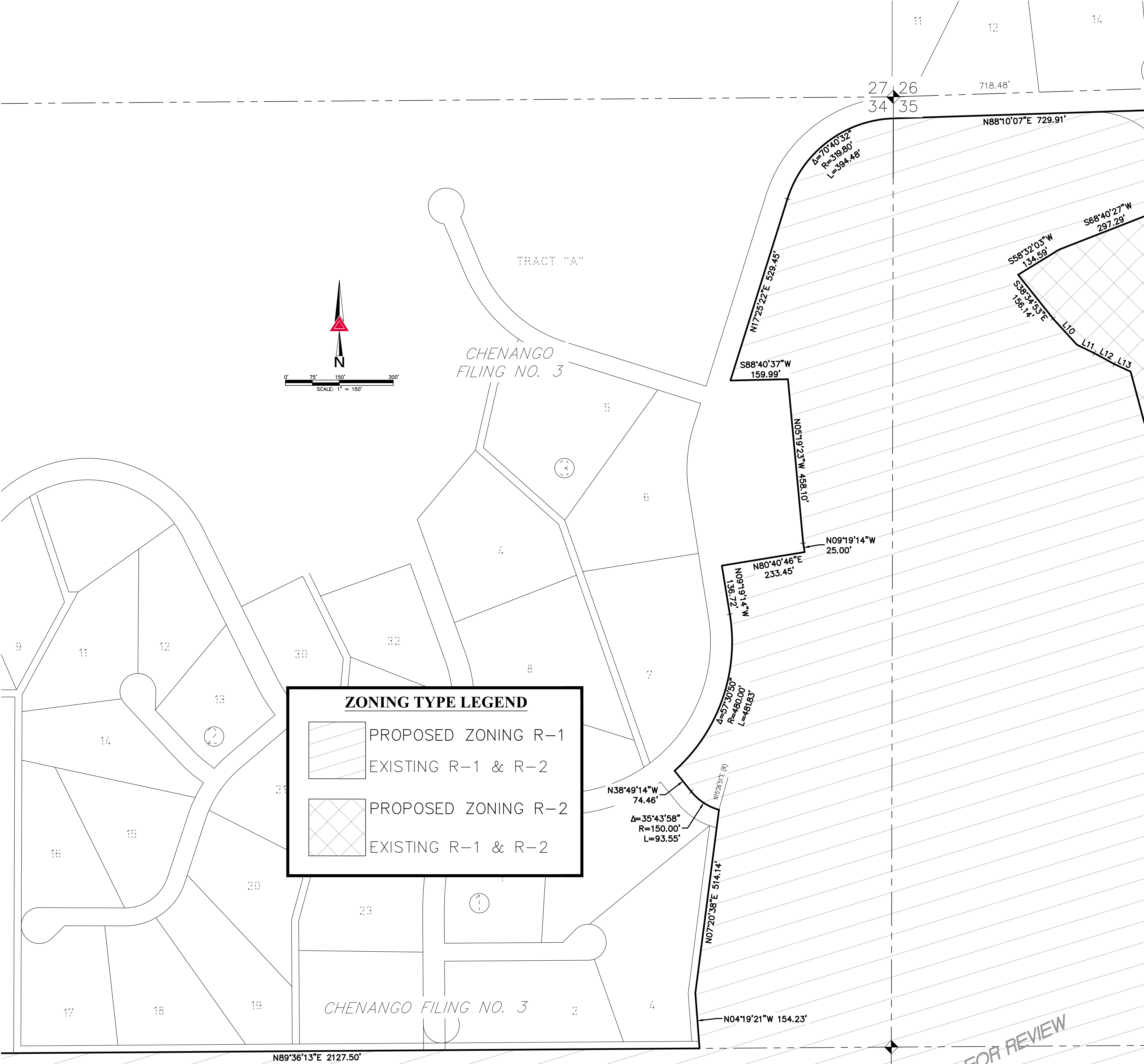
