COMMENCING AT THE NORTHWEST CORNER OF SAID SECTION 34 FROM WHICH THE WEST QUARTER CORNER OF SAID SECTION 34 BEARS S00°07'39"W A DISTANCE OF 2648.35 FEET; THENCE S32°33'14"E A DISTANCE OF 1466.76 FEET TO THE NORTHWEST CORNER OF SAID LANDS, SAID POINT BEING THE POINT OF BEGINNING; THENCE N89°37'35"E A DISTANCE OF 762.09 FEET; THENCE S00°07'13"W A DISTANCE OF 245.01 FEET; THENCE S89°37'35"W A DISTANCE OF 762.12 FEET; THENCE N00°07'39"E A DISTANCE OF 245.01 FEET TO THE POINT OF BEGINNING.

ALL LINEAL DISTANCES ARE REPRESENTED IN U.S. SURVEY FEET.





