PROPERTY DESCRIPTION**

THAT CERTAIN PARCEL OF LAND LYING WITHIN THE NORTHWEST QUARTER OF SECTION 12, TOWNSHIP 3 SOUTH, RANGE 66 WEST OF THE SIXTH PRINCIPAL MERIDIAN, IN THE CITY OF AURORA, COUNTY OF ADAMS, STATE OF COLORADO, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTH QUARTER CORNER OF SAID NORTHWEST QUARTER OF SECTION 11;
WHENCE THE EAST LINE OF SAID NORTHWEST QUARTER BEARS, SOUTH 00°07'19" WEST, 2660.75 FEET, WITH ALL BEARINGS CONTAINED HEREIN REFERENCED TO THE EAST LINE OF THE NORTHWEST QUARTER OF SECTION 12;
THENCE ALONG THE EAST LINE OF SAID NORTHWEST QUARTER SOUTH 00°07'19" WEST, 72.00 FEET TO THE **POINT OF BEGINNING**;
THENCE CONTINUING ALONG SAID EAST LINE, SOUTH 00°07'19" WEST, 2588.75 FEET TO THE CENTER QUARTER CORNER OF SAID SECTION;
THENCE ALONG THE SOUTH LINE OF SAID NORTHWEST QUARTER, NORTH 88°57'10" WEST, 2599.97 FEET TO POINT BEING 30.00 FEET EASTERLY OF THE WEST LINE OF SAID NORTHWEST QUARTER, SAID POINT ALSO BEING ON THE EASTERLY RIGHT-OF-WAY OF PICADILLY ROAD;
THENCE ALONG SAID EASTERLY RIGHT-OF-WAY OF PICADILLY ROAD, BEING 30.00 FEET EASTERLY AND PARALLEL TO THE WEST LINE OF SAID NORTHWEST QUARTER, NORTH 00°10'50" WEST, 2558.01 FEET TO A POINT ON THE SOUTHERLY RIGHT-OF-WAY OF EAST 64TH AVENUE, BEING 72.00 FEET SOUTHERLY AND PARALLEL WITH THE NORTH LINE OF SAID NORTHWEST QUARTER;
THENCE ALONG SAID SOUTHERLY RIGHT-OF-WAY LINE, SOUTH 89°37'57" EAST, 1109.60 FEET;
THENCE DEPARTING SAID RIGHT-OF-WAY LINE, SOUTH 00°22'03" WEST, 893.00 FEET;
THENCE SOUTH 89°37'57" EAST, 955.00 FEET;
THENCE NORTH 00°22'03" EAST, 893.00 FEET TO A POINT ON SAID SOUTHERLY RIGHT-OF-WAY LINE;
THENCE ALONG SAID RIGHT-OF-WAY LINE, SOUTH 89°37'57" EAST, 548.25 FEET TO THE **POINT OF BEGINNING**;

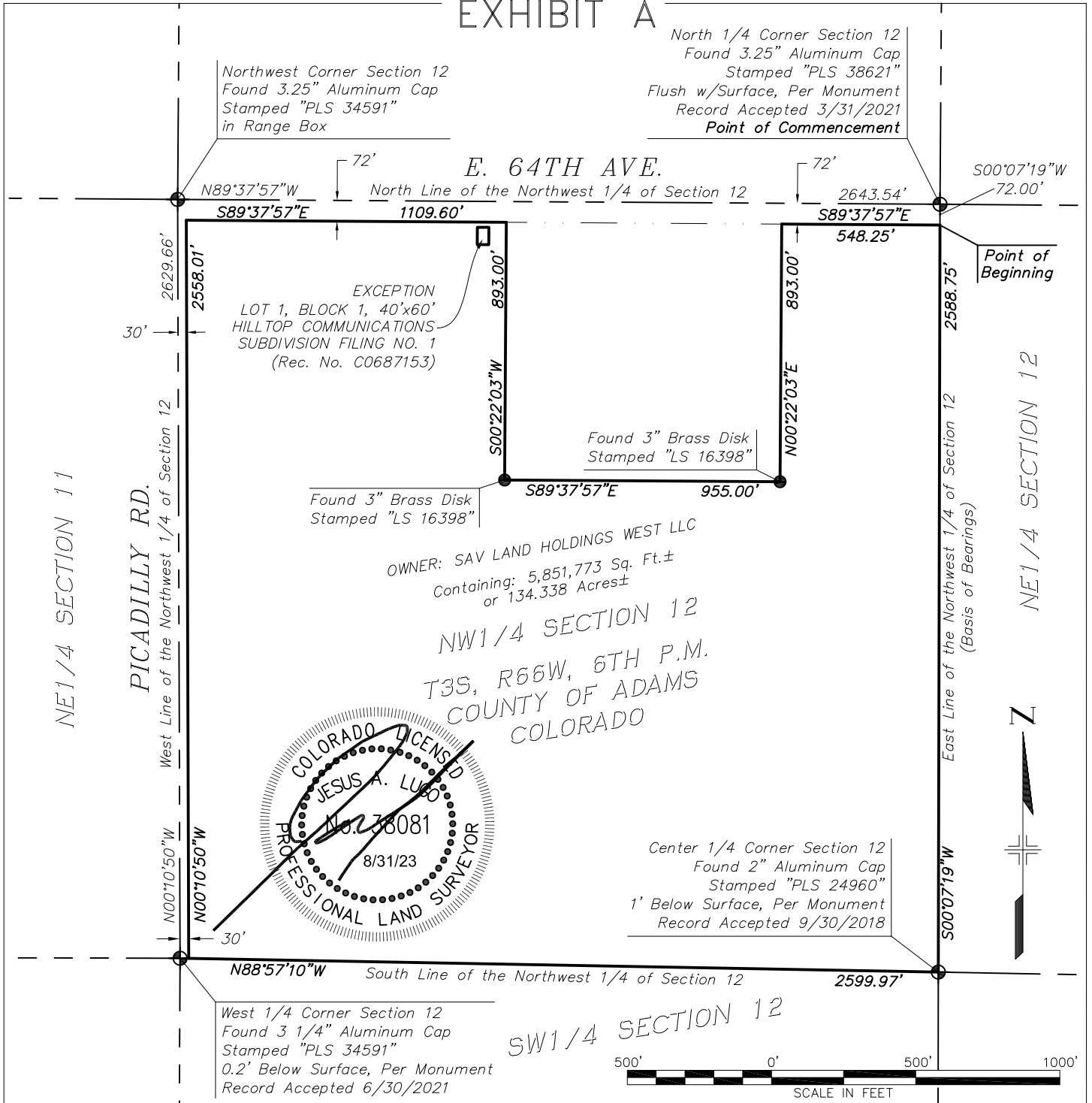
