THENCE SOUTH 61°37'59" EAST, A DISTANCE OF 2,003.47 FEET TO THE WESTERLY LINE OF SAID 26.00 FOOT WIDE PUBLIC ACCESS AND FIRE LANE EASEMENT AND THE **POINT OF BEGINNING**;

THENCE DEPARTING SAID WESTERLY LINE, SOUTH 79°04'46" EAST, A DISTANCE OF 26.00 FEET TO THE EASTERLY LINE OF SAID 26.00 FOOT WIDE PUBLIC ACCESS AND FIRE LANE EASEMENT AND THE **POINT OF TERMINATION**.


