All Requests for Modification or Requests for Alternative Materials/Methods must be clear and complete in order to be accepted for review. It is important that the applicant submitting a Request for Modification or Request for Alternative Materials/Method understands that our Division cannot waive the requirements of a particular code section, we can only review alternate ways to comply with the code. It is not a valid reason to submit a Request for Modification based on the cost of complying with the code. The conditions under which the Chief Building Official of the City of Aurora may approve an RFM or RFAM are limited to the provisions within chapter 1 of the International Codes which states:

- **Request for Modification:** Wherever there are practical difficulties involved in carrying out the provisions of this code, the building official shall have the authority to grant modifications for individual cases, upon application of the owner or owner's representative, provided the building official shall first find that special individual reason makes the strict letter of this code impractical and the modification is in compliance with the intent and purpose of this code and that such modification does not lessen health, accessibility, life and fire safety, or structural requirements.
- **Request for Alternative Material/Method:** Alternative materials, design and methods of construction and equipment. The provisions of this code are not intended to prevent the installation of any material or to prohibit any design or method of construction not specifically prescribed by this code, provided that any such alternative has been approved. An alternative material, design or method of construction shall be approved where the building official finds that the proposed design is satisfactory and complies with the intent of the provisions of this code, and that the material, method or work offered is, for the purpose intended, at least the equivalent of that prescribed in this code in quality, strength, effectiveness, fire resistance, durability and safety.

Please provide all of the following information in order to ensure a timely response to your request.

1. Specific Code Section applicable to your request IFC Section 503 - Fire Apparatus Access Roads, Section 503.1.1
2. Provide a clear description of why compliance with the stated code is impractical or an alternative method or material is preferred. Provide any supporting documentation needed to justify your position. (Note: The costs involved to comply with the code section are not considered as a valid consideration for a request for modifications.)

The existing building is sprinklered and the proposed building additions will be sprinklered as well. There is a berm, detention pond, and Wagner Channel located on the south side of the building. There is not sufficient room or grade to provide a fire access road in this area.

3. Describe the manner in which you will provide construction that is equal to or greater than what the specific code section requires. Describe how your conditions will meet the intent and purpose of the previously stated code section.

The entire building, including the new additions, will be sprinklered and the building can be accessed on the 3 other sides. IFC Section 503.1.1 provides two exceptions to allow the access road to be greater than 150 feet; 1) the building is equipped throughout with an approved automatic sprinkler system, or, 2) access roads cannot be installed because of location on property, topography, waterways, nonnegotiable grades or other similar conditions. This site meets both of these exceptions.
