

# EXHIBIT A

## LEGAL DESCRIPTION:

A PARCEL OF LAND SITUATED IN THE NORTH HALF OF SECTION 12, TOWNSHIP 4 SOUTH, RANGE 66 WEST OF THE SIXTH PRINCIPAL MERIDIAN, CITY OR AURORA, COUNTY OF ARAPAHOE, STATE OF COLORADO, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

**COMMENCING** AT THE NORTH QUARTER CORNER OF SAID SECTION 12 AND CONSIDERING THE NORTH LINE OF THE NORTHWEST QUARTER OF SAID SECTION 12 TO BEAR NORTH 89°17'33" EAST, WITH ALL BEARINGS CONTAINED HEREIN RELATIVE THERETO;

THENCE SOUTH 00°25'28" EAST ALONG THE EAST LINE OF THE NORTHWEST QUARTER OF SAID SECTION 12 A DISTANCE OF 37.00 FEET TO A LINE 37.00 FEET SOUTH OF AND PARALLEL WITH THE NORTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION 12 AND THE **POINT OF BEGINNING**;

THENCE NORTH 89°17'01" EAST ALONG SAID PARALLEL LINE A DISTANCE OF 534.23 FEET TO A POINT OF CURVATURE;

THENCE ALONG A CURVE TO THE RIGHT HAVING A CENTRAL ANGLE OF 90°00'00", A RADIUS OF 20.00 FEET, AN ARC LENGTH OF 31.42 FEET AND A CHORD THAT BEARS SOUTH 45°42'59" EAST A DISTANCE OF 28.28 FEET;

THENCE SOUTH 00°42'59" EAST A DISTANCE OF 721.84 FEET;

THENCE SOUTH 89°17'01" WEST A DISTANCE OF 1,078.60 FEET TO A POINT OF CURVATURE;

THENCE ALONG A CURVE TO THE LEFT HAVING A CENTRAL ANGLE OF 24°04'21", A RADIUS OF 450.00 FEET, AN ARC LENGTH OF 189.07 FEET AND A CHORD THAT BEARS SOUTH 77°14'50" WEST A DISTANCE OF 187.68 FEET;

THENCE SOUTH 65°12'40" WEST A DISTANCE OF 186.81 FEET;

THENCE NORTH 24°47'20" WEST A DISTANCE OF 218.77 FEET TO A POINT OF CURVATURE;

THENCE NORTH  $89^{\circ}17'33''$  EAST ALONG SAID PARALLEL LINE A DISTANCE OF 1,124.22 FEET TO THE **POINT OF BEGINNING**;

SAID PARCEL CONTAINS AN AREA OF 1,227,339 SQUARE FEET, OR 28.176 ACRES, MORE OR LESS.

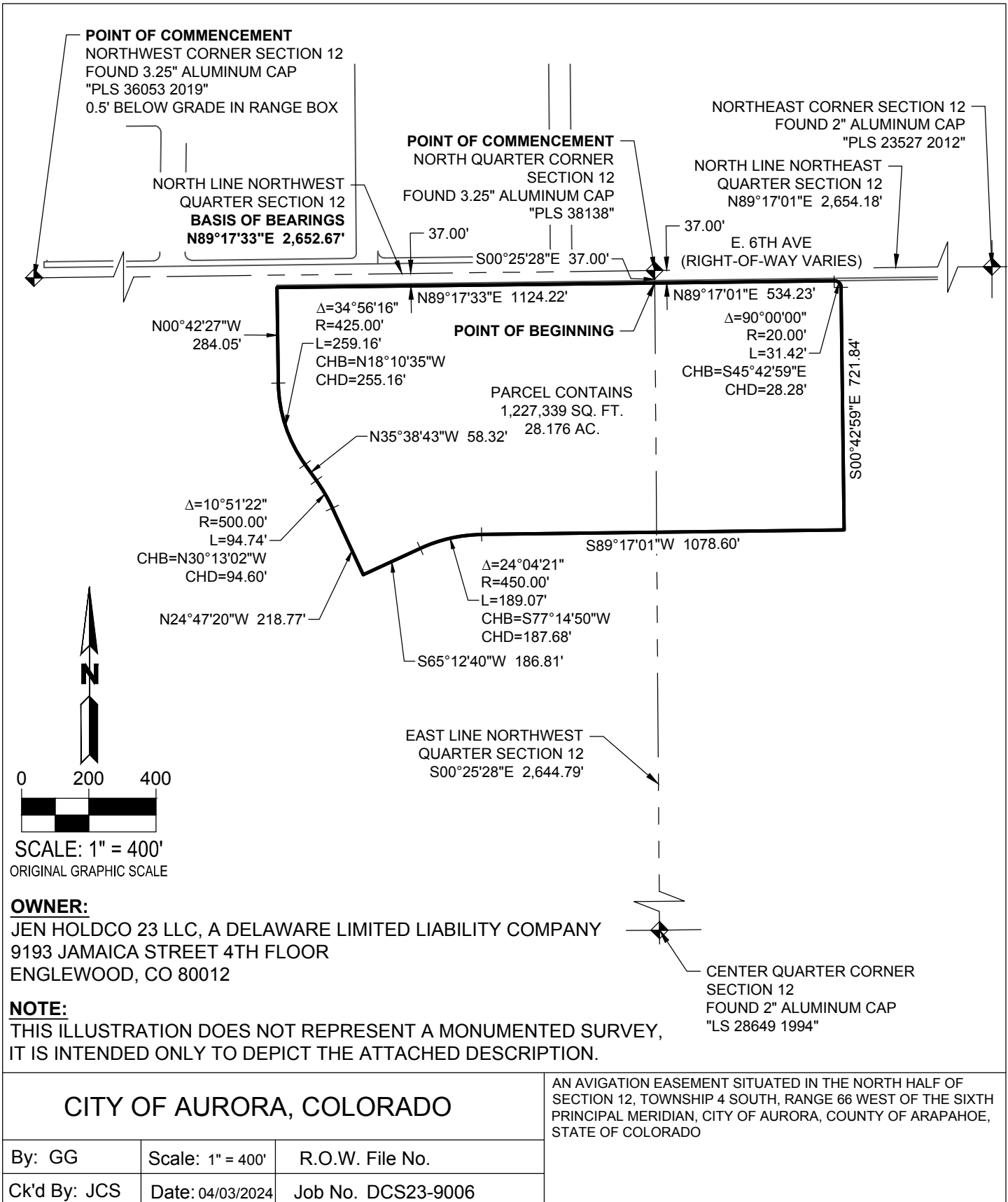
