KNOW ALL PEOPLE BY THESE PRESENTS THAT THE UNDERSIGNED WARRANT THEY ARE THE OWNERS OF LOTS 1 AND 2, BLOCK 1, KAISER AURORA CENTRETECH PARK SUBDIVISION FILING NO. 1, RECEPTION NO. R2284406, AND LOT 4, BLOCK 1, AURORA CENTRETECH PARK SUBDIVISION FILING NO. 3, RECEPTION NO. R2250416, TOGETHER WITH A PORTION OF VACATED EAST FIRST AVENUE, BEING LOCATED IN THE SOUTHEAST QUARTER OF SECTION 8, TOWNSHIP 4 SOUTH, RANGE 66 WEST OF THE 6TH PRINCIPAL MERIDIAN, COUNTY OF ARAPAHOE, STATE OF COLORADO, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

**BEARS OF BEARINGS:**  
 BEARINGS ARE BASED ON THE NORTH LINE OF THE SOUTHEAST QUARTER OF SAID SECTION 8 BEING ASSUMED TO BEAR SOUTH 89°57'19" EAST, A DISTANCE OF 2848.86 FEET BETWEEN THE FOLLOWING DESCRIBED MONUMENTS:  
 - THE EAST QUARTER CORNER OF SECTION 8 BEING A FOUND 3.25" ALUMINUM CAP, PLS 22100 IN RANGE BOX MATCHING MONUMENT RECORD FILED 6/30/07;  
 - THE CENTER QUARTER CORNER OF SECTION 8 BEING A FOUND 3.25" ALUMINUM CAP, PLS 22100 IN RANGE BOX MATCHING MONUMENT RECORD FILED 6/30/07

COMMENCING AT SAID EASTER QUARTER CORNER OF SECTION 8:  
 THENCE ALONG SAID NORTH LINE OF THE SOUTHEAST QUARTER SOUTH 89°57'19" WEST, A DISTANCE OF 55.12 FEET TO THE WESTERLY RIGHT-OF-WAY OF AIRPORT BOULEVARD AS DESCRIBED IN BOOK 2306 AT PAGE 771 AND THE POINT OF BEGINNING;  
 THENCE ALONG SAID WESTERLY RIGHT-OF-WAY SOUTH 00°00'30" WEST, A DISTANCE OF 550.00 FEET TO THE NORTHERLY RIGHT-OF-WAY OF EAST CENTRETECH PARKWAY AS SHOWN IN RECEPTION NO. R2250416;  
 THENCE ALONG SAID NORTHERLY RIGHT-OF-WAY THE FOLLOWING FOUR (4) COURSES AND DISTANCES:  
 1. THENCE ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 28.00 FEET, A CENTRAL ANGLE OF 90°00'00", WHOSE CHORD BEARS SOUTH 45°00'30" WEST A DISTANCE OF 38.36 FEET, FOR AN ARC DISTANCE OF 38.27 FEET;  
 2. THENCE NORTH 89°58'30" WEST, A DISTANCE OF 95.00 FEET;  
 3. THENCE SOUTH 89°58'18" WEST, A DISTANCE OF 130.00 FEET;  
 4. THENCE NORTH 89°58'30" WEST, A DISTANCE OF 960.83 FEET TO THE SOUTHWEST CORNER OF SAID LOT 1, BLOCK 1, KAISER AURORA CENTRETECH PARK SUBDIVISION FILING NO. 1;  
 THENCE ALONG THE WESTERLY LINE OF SAID LOT 1 NORTH 00°00'30" EAST, A DISTANCE OF 580.86 FEET TO SAID NORTHERLY LINE OF SAID SOUTHEAST QUARTER OF SECTION 8;  
 THENCE ALONG SAID NORTHERLY LINE NORTH 89°57'19" EAST, A DISTANCE OF 1,210.44 FEET TO THE POINT OF BEGINNING, CONTAINING 702,370 SQUARE FEET OR 16.124 ACRES, MORE OR LESS.

**COVENANTS**

THE UNDERSIGNED OWNER(S), FOR THEMSELVES, THEIR HEIRS, SUCCESSORS AND ASSIGNS, COVENANT AND AGREE WITH THE CITY OF AURORA:

NO STRUCTURE CONSTRUCTED ON ANY PORTION OF THE PLATTED LAND SHOWN HEREIN SHALL BE OCCUPIED OR USED UNLESS AND UNTIL ALL PUBLIC IMPROVEMENTS, AS DEFINED BY CHAPTER 148 OF THE CITY CODE OF AURORA, COLORADO, ARE IN PLACE AND ACCEPTED BY THE CITY THROUGH FUNDS OR OTHER SECURITY FOR THE SAME ARE ESCROWED WITH THE CITY OF AURORA AND A CERTIFICATE OF OCCUPANCY HAS BEEN ISSUED BY THE CITY.

ALL ELECTRICAL, COMMUNITY UTILITY LINES AND SERVICES, AND STREET LIGHTING CIRCUITS, EXCEPT AS PROVIDED IN SECTION 128-505 OF THE CITY CODE AS THE SAME MAY BE AMENDED FROM TIME TO TIME, SHALL BE INSTALLED UNDERGROUND;

ALL CROSSINGS OR ENCROACHMENTS, INCLUDING BUT NOT LIMITED, TO PRIVATE LANDSCAPE IRRIGATION SYSTEMS, UNDERDRAINS, OR PRIVATE UTILITIES INTO EASEMENTS OWNED BY THE CITY OF AURORA ARE ACKNOWLEDGED BY THE UNDERSIGNED AS BEING SUBJECT TO THE CITY OF AURORA'S USE AND OCCUPANCY OF SAID EASEMENTS AND RIGHTS-OF-WAY. THE UNDERSIGNED, THEIR SUCCESSORS AND ASSIGNS, HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS THE CITY OF AURORA FOR ANY LOSS, DAMAGE, OR REPAIR TO PRIVATE LANDSCAPE IRRIGATION SYSTEMS, UNDERDRAINS, OR PRIVATE UTILITIES THAT MAY RESULT FROM THE CITY OF AURORA'S USE AND OCCUPANCY OR EXERCISE OF ITS RIGHTS IN SAID EASEMENTS AND RIGHTS-OF-WAY. THE UNDERSIGNED, ITS SUCCESSORS AND ASSIGNS, FURTHER AGREES TO REMOVE, REPAIR, REPLACE, RELOCATE, MODIFY, OR OTHERWISE ADJUST SAID PRIVATE LANDSCAPE IRRIGATION SYSTEMS, UNDERDRAINS, PRIVATE DETENTION POND AND DRAINAGE FEATURES, OR PRIVATE UTILITIES UPON REQUEST FROM THE CITY OF AURORA AND AT NO EXPENSE TO THE CITY OF AURORA.

2. ALL DIMENSIONS SHOWN HEREIN ARE IN U.S. SURVEY FEET. ALL BEARINGS SHOWN HEREON ARE IN DEGREE-MINUTE-SECOND.
3. ANY PERSON WHO KNOWINGLY REMOVES, ALTERS OR DEFACES ANY PUBLIC LAND SURVEY MONUMENT OR LAND SURVEY BOUNDARY MONUMENT OR ACCESSORY COMITS A CLASS TWO (2) MISDEMEANOR PURSUANT TO STATE STATUTE 18-4-508, C.R.S.

THE PURPOSE OF THIS PLAT IS TO REVERSE LOT LINES TO CREATE 2 LOTS INSTEAD OF 3 LOTS AND A VACATED PORTION OF EAST FIRST AVENUE. NO OTHER CHANGES ARE MADE HEREBY.
8. THE EASEMENT AREA WITHIN EACH LOT OR TRACT IS TO BE CONTINUOUSLY MAINTAINED BY THE OWNER OF THE LOT OR TRACT EXCEPTING THE CITY OF AURORA FROM SUCH RESPONSIBILITY. ANY STRUCTURES INCONSISTENT WITH THE USE GRANTED IN THE EASEMENT ARE PROHIBITED.

10. ALL OWNERS OF LOTS OR TRACTS ADJACENT TO EAST CENTRETECH PARKWAY AND AIRPORT BOULEVARD SHALL BE REQUIRED TO COMPLY WITH REQUIREMENTS OF THE AURORA CITY CODE RESTRICTING THE ABILITY TO BUILD A FENCE ALONG THOSE STREETS OR THE TYPES AND SIZES OF FENCES THAT CAN BE BUILT ALONG THOSE STREETS.
