Pursuant to the zone district regulations and Section 146-5.4.3.B.3.c of the Unified Development Ordinance, City of Aurora, Colorado, the administrative application for Fine Parking Building 6 Site Plan is:

This decision shall become effective after the second City Council meeting following notice of this decision to City Council. Prior to the effective date of this decision, City Council may move to consider the application and affirm, overrule or modify this decision. You may also appeal this decision to the City Council. An appeal must be filed with the City Manager’s office within ten calendar days from the date of this decision. Abutting property owners may also file an appeal within ten calendar days from the date of this decision.

Based upon the information contained in the application, the following are findings of fact as applied to the criteria for approval in Section 146-5.4.3.B.3.c of the Unified Development Ordinance:

*Minor Site Plan approval criteria are found in Section 146-5.4.3.B.3.c. of the Unified Development Ordinance, and may be summarized as follows: The Minor Site Plan shall be approved only if the application complies with the applicable standards in this UDO, other adopted City regulations, any approved Master Plan that includes the property, and any conditions specifically applied to development of the property by the Planning and Zoning Commission or City Council in a prior decision affecting the property. If the application does not comply with those standards, the Planning Director will notify the applicant of what other permits, approvals, or changes to the application are required for compliance.*

The Site Plan as proposed:

- Complies with all applicable standards in the UDO and is consistent with the goals defined in the Industry Hub Placetype and the “Strong Economy” goals of the Aurora Places Comprehensive Plan;
- The Site Plan follows the standards set forth by the approved Fine Point Business Park Master Plan;

Condition of Approval:

1. Resolution of outstanding technical issues prior to the recordation of the Site Plan and issuance of building permits
