Hi Debbie,

Thank for your initial review and providing us with those preliminary concerns prior to routing. Based on your notes, we've noted some additional revision clouds on the Site Plan and updated the narrative. In addition, below are our responses to those initial questions.

1. Are you adding another smoking shelter? **No additional shelter, the shelter was relocated slightly north of the previous location.**
2. Are you changing the bike rack style? 14 bike spaces in 2 racks? **Correct, a revision cloud has been added to sheet 63 to reflect updated bike rack style and to the Site Data Table to reflect the just in bike spaces provided.**
3. You've removed the pergola. **Please add some type of shade structure. We understand the Site Plan was recorded showing a pergola. However, during the CD review and approval process the pergola was removed (we've included the City approved CDs for reference) therefore we are requesting the removal in the Site Plan to keep both documents consistent.**
4. Check your base map appears to be different than the file of record in the area shown below from Sheet 7. **Per the CD review process, Post Indicator Valves and bollards have been removed and replaced with gate valves further away from the building. These changes have been noted as part of the revision clouds in this amendment request.**
