Thank you for your third submission, which we started to process on May 20, 2020. We reviewed it and attached our comments along with this cover letter. Your submittal addressed most of the comments. However, due to the recent adjustment request, you will need to provide a letter outlining how the site plan meets the criteria set forth in the Unified Development Ordinance. Accordingly, please provide another site plan submission that include the adjustments. **Please revise your previous work and upload the adjustment letter, updated elevations and a new submission on or before June 19, 2020.**

Note that all our comments are numbered. When you resubmit, include a cover letter specifically responding to each item. The Planning Department reserves the right to reject any resubmissions that fail to address these items. If you have made any other changes to your documents other than those requested, be sure to also specifically list them in your letter.

Your estimated Planning Commission hearing date is scheduled for July 8, 2020. Please remember that all abutter notices for public hearings must be sent and the site notices must be posted at least 10 days prior to the hearing date. These notifications are your responsibility and the lack of proper notification will cause the public hearing date to be postponed. It is important that you obtain an updated list of adjacent property owners from the county before the notices are sent out. Take all necessary steps to ensure an accurate list is obtained.

- 1B. A request for a Major Adjustment has now been made as indicated on Sheet 7. Per Section 146-5.4.4.D, please provide a letter describing the adjustment requested, what will be requested and how the request for the adjustment meets the criteria of approval found in the UDO. The City suggests additional site-wide landscaping be incorporated as well as enhanced elevation features to meet the criteria of approval requirements.

- 2A. Current issues have been resolved. Please see comments regarding meeting the Major Adjustment Criteria of Approval.

Please eliminate any line work outside of the target area. Please contact me if you need additional information about this digital file.
