COMMENCING AT THE EAST QUARTER CORNER OF SAID SECTION 25, THENCE S89°26'34"W A DISTANCE OF 75.00 FEET TO THE POINT OF BEGINNING;

THENCE ALONG THE SOUTHERLY LINE OF SAID NORTHWEST QUARTER S89°27'44"W A DISTANCE OF 2188.21 FEET TO A POINT ON THE EASTERLY RIGHT OF WAY LINE OF E-470 FOUND AT REC#A7051461; THENCE ALONG SAID EASTERLY RIGHT OF WAY LINE THE FOLLOWING THREE (3) CONSECUTIVE COURSES:

- 1) N10°42'50"W A DISTANCE OF 738.52 FEET;
- 2) THENCE N01°22'25"W A DISTANCE OF 195.74 FEET;
- 3) THENCE N06°35'27"W A DISTANCE OF 360.83 FEET;

THENCE N89°25'57"E A DISTANCE OF 1964.56 FEET;

THENCE S00°27'01"E A DISTANCE OF 560.00 FEET;

THENCE N89°25'58"E A DISTANCE OF 397.00 FEET;

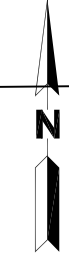

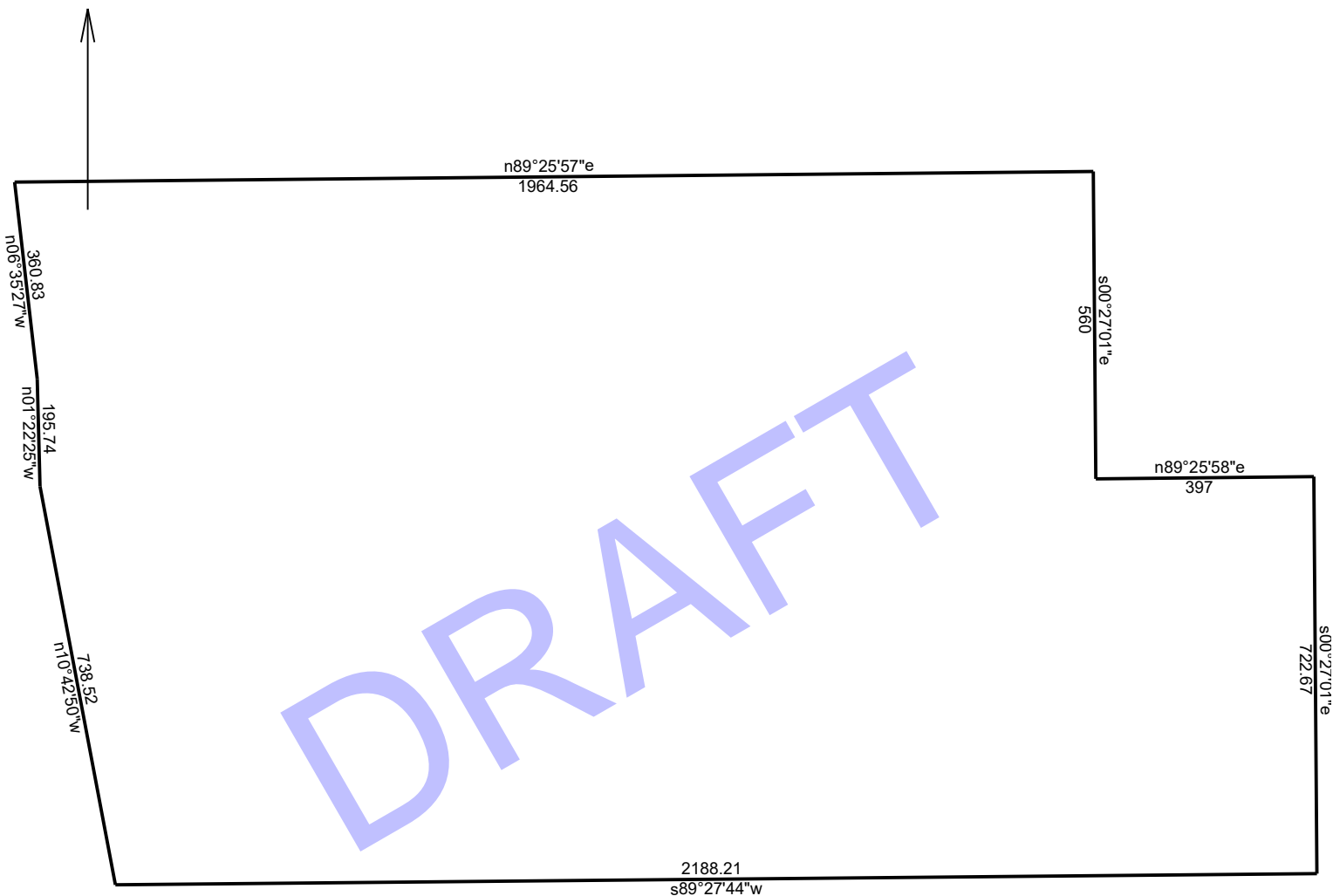
