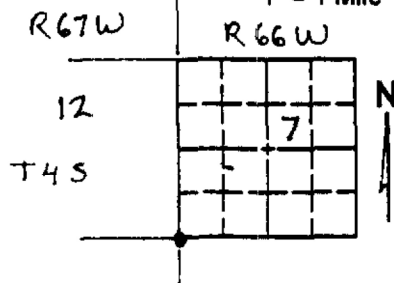

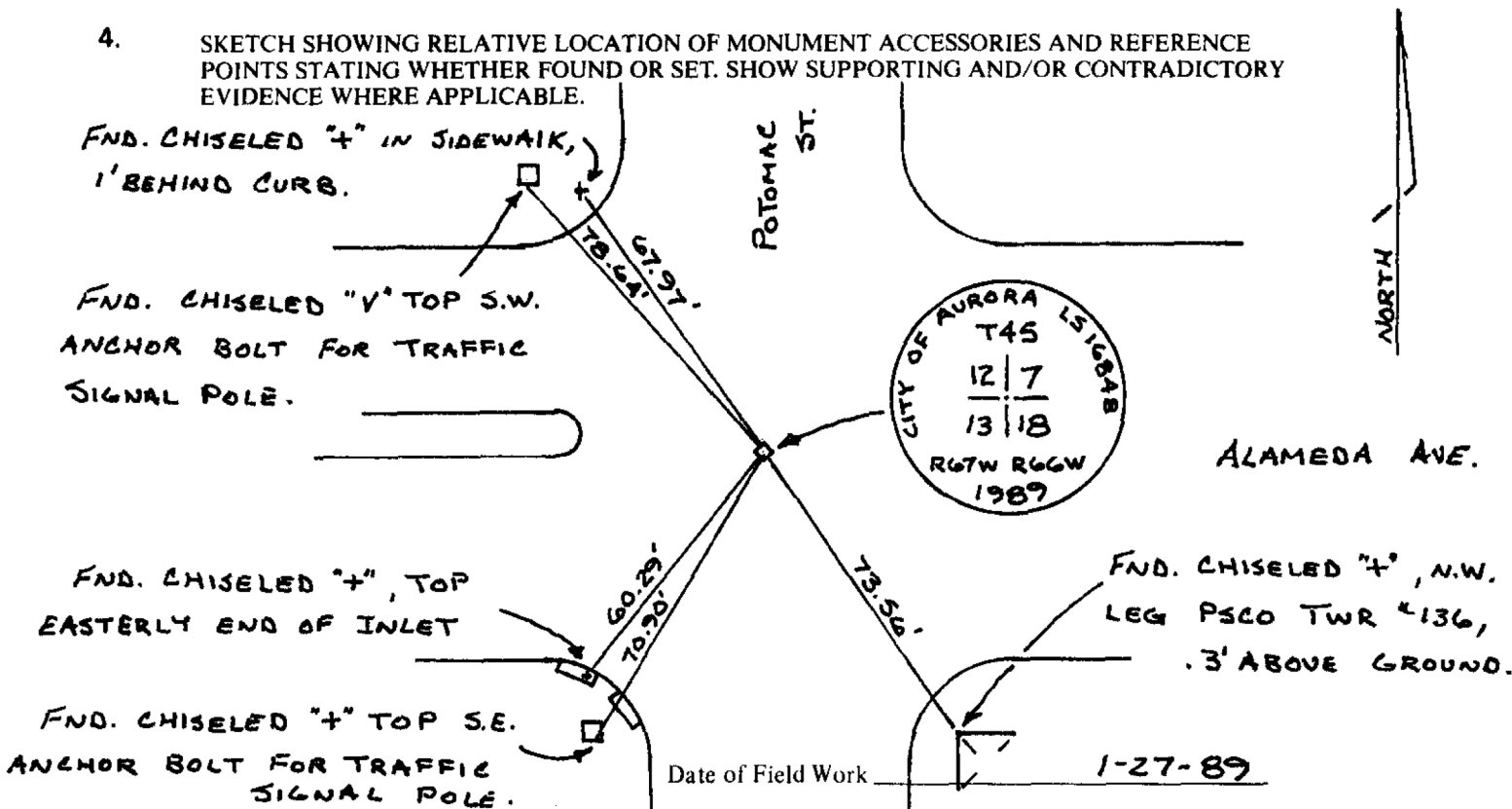
Found a 1 1/4" dia. steel pin 1.3' below surface, in COA range box. There was a water valve box & lid set over the COA range box, at the surface.

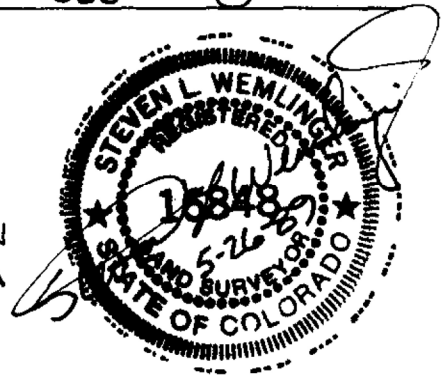
